

Leadership and Advocacy Conference Update

LAC21, ACEP's annual Leadership and Advocacy Conference in DC was well worth the trip, even though our meetings with **congressional staffers** were virtual. It was wonderful to see the **ACEP leadership** live and in person. I always relish the opportunity to meet members of the **US House and Senate**.

Many of us were shocked by the first-hand accounts of **January 6th**. It was terrifying for them. Hearing **Dr. Raul Ruiz**, a US Congressman from the great state of California, and emergency physician, describe helping others put on their gas masks, will be something I won't easily forget.

We heard from many eloquent speakers, including **Sen. Tim Kaine (D-VA)**, who spoke about the **Dr. Lorna Breen Health Care Provider Protection Act**, which he co-sponsored. Dr. Lorna Breen was an emergency physician from Columbia Presbyterian, who, during the height of the COVID pandemic, took her own life. This important legislation seeks to **remove barriers to accessing care and treatment**(including consideration of **stigma and**

licensing concerns) and support grants to study and develop policies preventing **burnout and depression** among health care clinicians. I urge you to call or email **Senators Leahy and Sanders** since it passed the house on August 6th!!

The second piece of legislation involves rescinding the “**X waiver**,” required for prescribing **buprenorphine**. This would remove the cumbersome waiver and allow all health care practitioners with a standard controlled medication license to prescribe.

Finally, we addressed the upcoming Medicare cuts to physicians’ reimbursement. You can read more about the issues on [ACEP's website](#). I would be happy to discuss any further issues.

Hope you are all asking for Oct 23-28 off for the ACEP council meeting on the 23rd & 24th and [ACEP21](#) on the 25-28 in Boston! I am defending a resolution I wrote that I am told is destined to fail miserably. Would love some local support!!!


